## NOTICE TO THE COURT REGARDING POST-JUDGMENT DISCOVERY

The Government's position is that no post-judgment discovery should be ordered in this case for the reasons previously stated. To the extent this Court disagrees, U.S. Citizenship and Immigration Services ("USCIS") is prepared to make available for deposition Richard T. Murray, Division Chief of the Immigrant Investor Program Office, for the limited purpose of obtaining testimony directly related to the steps taken by USCIS to implement, in good faith, the International Entrepreneur Rule, following this Court's December 1, 2017 order.

In addition, USCIS is prepared to provide within a reasonable timeframe, with respect to the International Entrepreneur Rule, documentation USCIS believes is sufficient to establish that the rule has been implemented consistent with this Court's December 1, 2017 order. Such evidence would consist of copies of training materials, documents related to the development of the training materials, documentation related to identifying the adjudicators and supervisors who will adjudicate parole applications under 8 C.F.R § 212.19, documentation to confirm that steps were taken to adjudicate pending applications prior to the filing of plaintiff's motion, and meeting invites relating to setting up intake, developing training, providing training, and applying applicable regulations to cases. This production will be from December 1, 2017 (the

date of the Court's order) forward and will be subject to, and without waiver of, all applicable privileges.

This proposal should address any concerns the Court might have.
